1. This Certificate will NOT be accepted by the Grain Marketing Board Unless it has been signed by the farmer and witnessed.
2. A stop order fee of 2.5% will be deducted from the Farmer for each payment of this certificate.
3. (a) COTTON and GRAIN cannot be on the same form.
 (b) If GRAIN is stated above, the stop order will apply to ALL the following Grains unless individual Grains are specified: MAIZE, COFFEE, SORGHUM, SHELLED and UNSHELLED NUTS, SOYA BEANS, WHEAT, SUNFLOWER, MHUNGA, RAPOKO, RICE AND EDIBLE BEANS.
